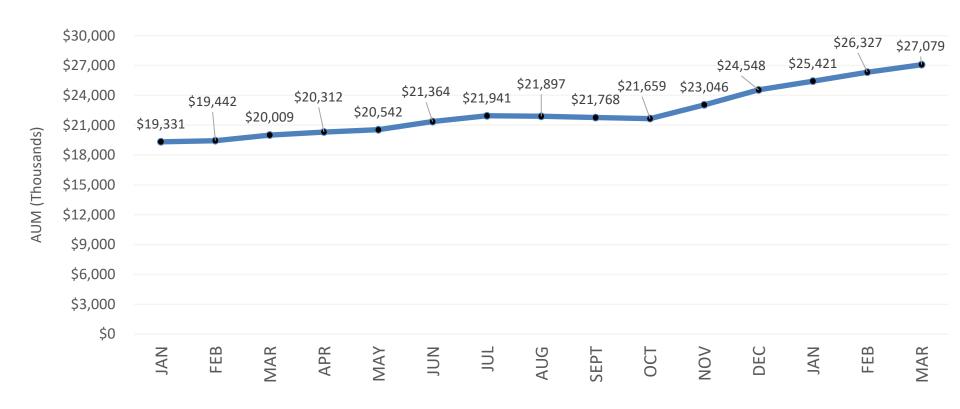

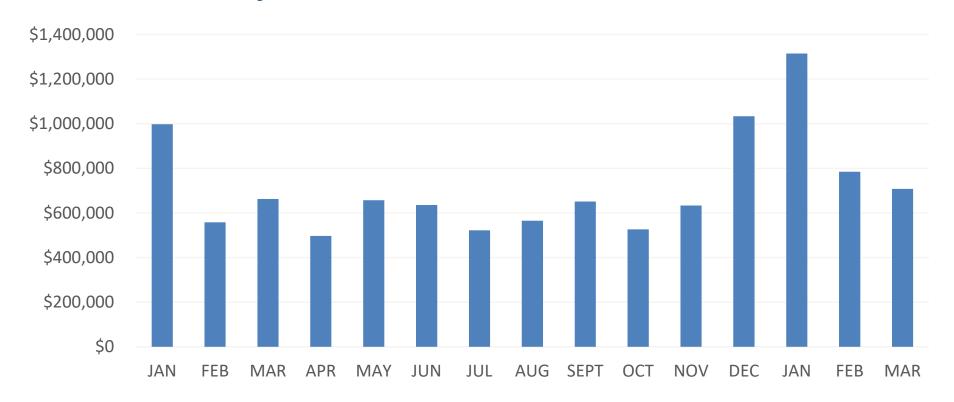


Total Assets by Month

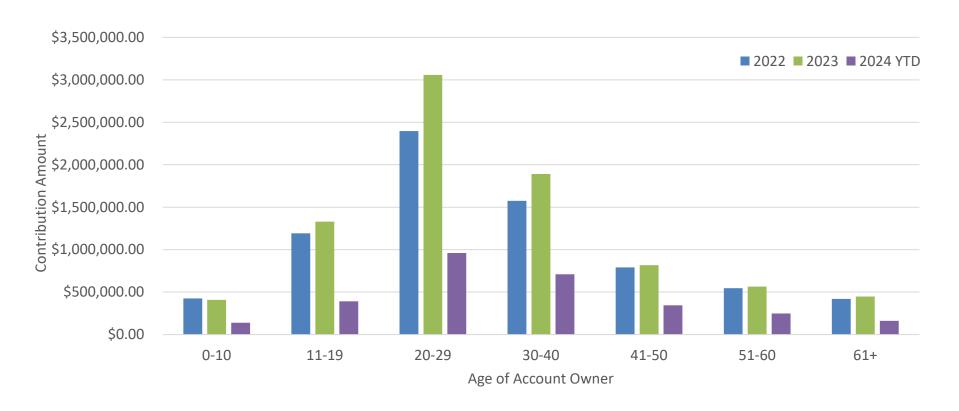

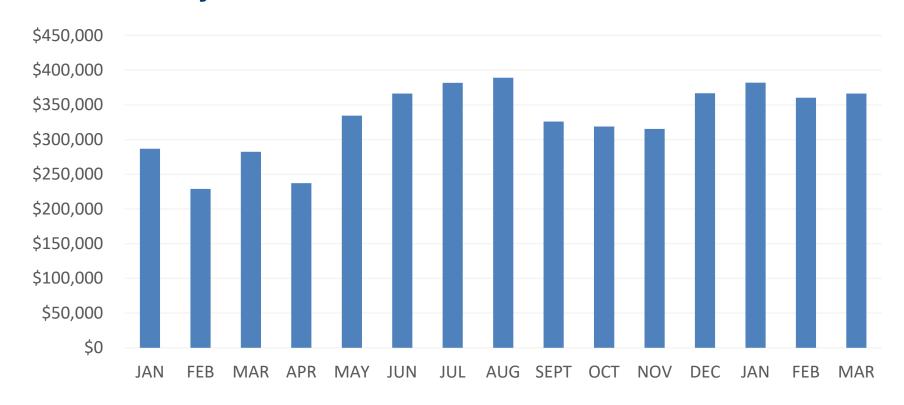
Contributions by Age Group







Distributions by Month







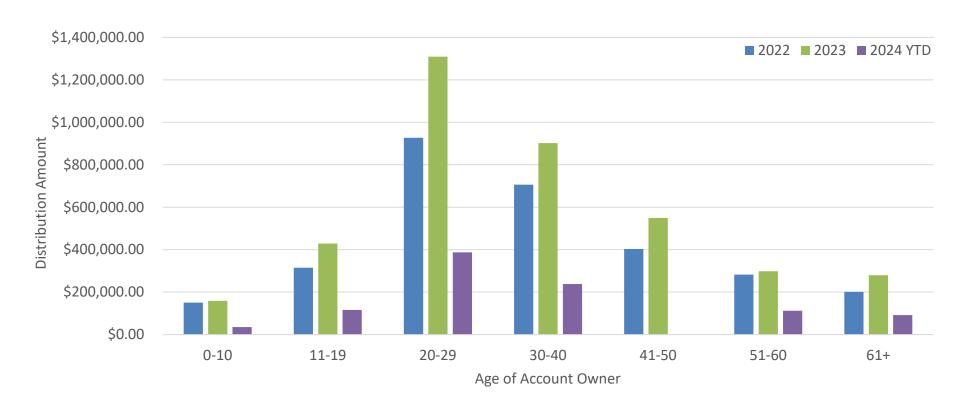

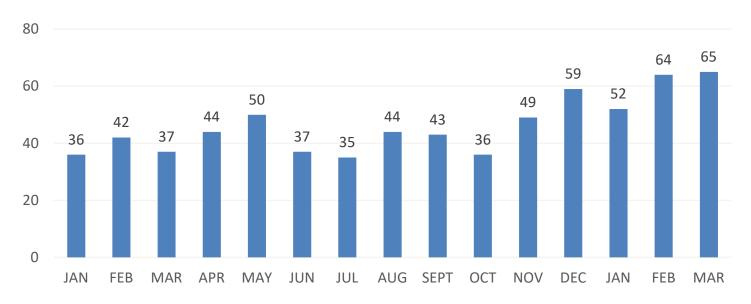
Distributions by Age Group
